CALL TO ACTION

SHORT SUMMARY OF THE ISSUE

Over the years, the left has given Justice Thomas and his family little rest from their accusations, lies, and malevolence. Most recently, they have smeared Justice Thomas with the lie that he has acted unethically, attacked his wife for her political opinions, and demanded he recuse himself from cases they want to win. All of the “ethics” accusations have been thoroughly debunked, and his wife has done nothing wrong. Not even the January 6th committee, though they tried, had anything to say about her political activities.

In May 2024, the left and the media also coordinated an attack on Justice Samuel Alito and called for investigations because an “Appeal to Heaven” flag flew at his vacation home in 2023, and an upside-down American flag flew at his Virginia home in 2021. The “Appeal to Heaven” flag is a well-loved flag that flew during the Revolutionary War under General Washington. His wife flew the upside-down American flag in response to a spat with a neighbor.

What are the real reasons for these attacks? First, the left is calling for both justices to recuse themselves from all cases affecting President Trump or having to do with January 6th. They don’t care about ethics or justice. They just want to win. We know this because they give a pass to liberal justices, no matter the shady ethics, never demanding they recuse themselves from cases.

There is another reason for the constant attacks on justices thought of as the “conservative” justices: the left’s fevered desire to pack the Supreme Court. When President Trump was allowed to fill three vacancies on the Court, the left howled that he was “packing” the Court and that the only way to “unpack” it was to allow a Democrat president to add four more justices, bringing the total number to thirteen.

It must be understood that the attacks on justices like Clarence Thomas and Samuel Alito are, first, attempts to bully them off certain cases. They are also attacks on the integrity of the Supreme Court as a whole, with the goal of destroying Americans’ confidence in the Court, and consequently softening the American people to the idea of additional justices.
