FACTS ABOUT CHILD SEX TRAFFICKING

DEFINITIONS

HUMAN TRAFFICKING: involves the use of force, fraud, or coercion to obtain some type of labor or commercial sex act (DHS.gov)

LABOR TRAFFICKING (a form of forced labor): The Trafficking Victims Protection Act of 2000 (TVPA) defines labor trafficking as: "The recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage or slavery." The TVPA also recognizes sex trafficking, which is discussed in a separate fact sheet. A modern-day form of slavery, labor trafficking is a fundamental violation of human rights (acf.hhs.gov)

DOMESTIC SERVITUDE (form of forced labor): a situation in which victims are forced to work against their own will, under the threat of violence or some other form of punishment, their freedom is restricted and a degree of ownership is exerted. Examples include: being required to clean houses. (acf.hhs.gov)

SEX TRAFFICKING: Sex trafficking occurs when someone uses force, fraud, or coercion to cause a commercial sex act with an adult or cause a minor to commit a commercial sex act (Shared Hope)

CHILD SEX TRAFFICKING: refers to the recruitment, harboring, transportation, provision, obtaining, patronizing, or soliciting of a minor for the purpose of a commercial sex act. Force, fraud or coercion do not need to be present for the crime to be considered child sex trafficking (justice.gov, humantraffickinghotline.org)

CHILD EXPLOITATION: is a broad term that encompasses all forms of child sexual exploitation. This may include many of the other terms on this list, such as child sexual abuse material, child sex trafficking, and others like sextortion.

ONLINE EXPLOITATION

CHILD SEXUAL ABUSE MATERIAL (CSAM): refers to any content that depicts sexually explicit activities involving a child. Visual depictions include photographs, videos, live streaming, and digital or computer generated images indistinguishable from an actual minor. CSAM better describes the reality of this crime, rather than the legal term of child pornography. It's important we use terminology that reflects the impact of this crime on its victims (Thorn.org). **"At any given time, there is an estimated 750,000 child predators online — and they all have a key to your house via the Internet"** (FBI, nd)

STATISTICS

This is one of the broadest ways to talk about the issue as a whole, rather than the individual and nuanced pieces (Thorn.org)

- Human trafficking is the 2nd largest illicit industry in the U.S., 2nd only to the drug trade (UNICEF, nd)
- There are 40.3 million trafficked persons globally today and 25% of them are children (Liberate Children, International Labour Organization) Forms of Child Trafficking include forced marriage, begging, sweatshops, pornography, migrant farming domestic labor, sextourism, armed groups (commonly known as child soldiers) (Unicef)
- Sex trafficking is the most common type of trafficking in the US. In North America 72% of detected survivors were trafficked for sexual exploitation. (UNODC, HTIP report 2020)
- 70 million CSAM files are estimated in 2019. 78% of this file are children under the age of 12 (Thorn)
- The extent of family involvement in child trafficking 4x higher than in cases of adult trafficking (CTDC)
- 53% of all male victims trafficked into sexual exploitation are children. (CTDC)
- Child sex trafficking has been reported in all 50 U.S. States. (NCMEC)
- A higher percentage of identified children are trafficked for sexual exploitation than for forced labor (UNODC)

TRAFFICKING AND OPEN BORDERS

A huge factor in child sex trafficking in America is our open border and lack of immigration enforcement. Low-immigration, Pro-immigrant

Biden Administration and Congressional Democrats Facilitated 'Explosion' in Illegal Alien Child Labor¹

March 14, 2023

A recent investigation from the New York Times exposes² the fact that illegal alien minors are “arriving in record numbers” and “ending up in dangerous jobs that violate child labor laws” across the United States. The Times reports that the exploitation of child labor “has exploded since 2021”, and that the “number of unaccompanied minors entering the United States climbed to a high of 130,000 last year — three times what it was five years earlier”. The article is an indictment of the Biden administration’s open-border policies, the results of which were entirely predictable. The Times explains:

These are not children who have stolen into the country undetected. The federal government knows they are in the United States, and the Department of Health and Human Services is responsible for ensuring sponsors will support them and protect them from trafficking or exploitation.

But as more and more children have arrived, the Biden White House has ramped up demands on staffers to move the children quickly out of shelters and release them to adults. Caseworkers say they

rush through vetting sponsors.

While H.H.S. checks on all minors by calling them a month after they begin living with their sponsors, data obtained by The Times showed that over the last two years, the agency could not reach more than 85,000 children. Overall, the agency lost immediate contact with a third of migrant children.

...

In the last two years alone, more than 250,000 children have entered the United States by themselves.

ICE's criminal investigators in Homeland Security Investigations (HSI) have opened an investigation into possible human trafficking related to the DOL investigation, but as explained below, ICE has been largely blocked by Congress from making arrests of sponsors trafficking children to the border, and also largely barred from conducting worksite investigations that might uncover this type of exploitation. Put differently, because of the policies of the Biden administration and the Democrats in Congress, ICE is opening an investigation into something it could have stopped long before it developed into a nationwide problem with victims in multiple states.

Bombshell NYT Report Shows White House Aware of Alien Child Abuses³

April 19, 2023

DHS's UAC [unaccompanied alien child] encounters soon soared, however, beginning in FY 2009. That's when the Democratically controlled 110th Congress passed the Trafficking Victims Protection Reauthorization Act of 2008⁴ (TVPRA).

That 2008 act has subsequently served as a magnet drawing minors to enter illegally. By FY 2012, three fiscal years after the TVPRA was passed, Border Patrol apprehended more than 24,400 UACs⁵ at the Southwest border, a figure that climbed to 38,750 in FY 2013 and 68,500 in FY 2014.

Not surprisingly, given the preferential treatment TVPRA offers to UACs who aren't from Mexico or Canada, the number and percentage of UACs apprehended at the border from non-contiguous countries skyrocketed.

Since February 2021, Border Patrol has apprehended more than 286,430 UACs⁶ from non-contiguous countries at the Southwest border, and CBP officers at the ports there have stopped an additional 2,309 — 288,739 in total.

[T]he UAC problem has worsened, particularly under the Biden administration. In FY 2022, Border Patrol agents apprehended more than 149,000 unaccompanied alien children at the Southwest border, nearly 86 percent of whom weren't from Mexico or Canada, as well as more than 54,500 new UACs from non-contiguous countries in the first five months of FY 2023.

ORR — which has struggled in the past to protect unaccompanied alien children⁷ — is now overwhelmed and failing in those responsibilities, as it rushes to clear its limited shelter space by quickly placing children with sponsors in the United States.

In September, HHS's Office of Inspector General (OIG) — the department's watchdog — issued a report⁸ blasting the office's performance in caring for, tracking, and releasing UACs encountered at the Southwest border and entrusted to ORR's care at its emergency intake sites.

Insufficient vetting of sponsors has been a problem¹⁰ that has plagued ORR's UAC program on and off for years, as my colleague Jessica Vaughan explained in 2015.

The Trump administration attempted to address this vetting problem,¹¹ including by requiring HHS to provide information on sponsors to DHS. Consequently, however, the time UACs spent in ORR care while proper sponsors were located increased from 48 days in FY 2017¹² to 102 days in FY 2020, which prompted complaints from — among others — then-candidate Joe Biden.

Border Sex Trafficking Cases Should Challenge *Sound of Freedom* Skeptics¹³

August 4, 2023

Since the film's release, federal prosecutors under Biden's Attorney General Merrick Garland have written horrifying child sex-trafficking tales into their prosecution of very recent court cases, which have received little-to-no media coverage or skepticism challenging their credibility. The details of these prosecutions are plenty horrifying enough to qualify for any Hollywood movie around Halloween time.

So would the FBI's just-concluded July "Operation Cross Country"¹⁴ with the National Center for Missing and Exploited Children, which rescued 200 sex trafficking victims, 59 of whom were minors, in just two weeks of trying.

"Sex traffickers exploit and endanger some of the most vulnerable members of our society and cause their victims unimaginable harm," Attorney General Garland said in a prepared statement announcing the rescues of sex-trafficked children last month.

"Human traffickers prey on the most vulnerable members of our society, and their crimes scar victims — many of them children — for life," FBI Director Christopher Wray said in a press release.

Neither mention the obvious connection between this evil and their president's open-border and asylum policies, which without doubt make it far easier for sex traffickers like Mission, Texas, prostitution madam Rita Martinez and her son Genaro Fuentes, both of whom have just pleaded guilty¹⁵ to sex trafficking charges filed last year, to smuggle underage girls over the border and

promptly force them into sexual slavery.

This Martinez-Fuentes case and another recent one involving Cuban men who forced women they smuggled to prostitute themselves in Houston strip clubs show the inextricable bond between this odious form of human trafficking and lax border control and asylum policies. The lesson is that when border security is tight and fewer illegal immigrants are therefore crossing, less sex trafficking evil can be imported. Conversely, when border security and asylum policies are loose, more women and children will be trafficked, as has been the case under President Biden for nearly 30 months straight.

How Porous Borders Fuel Human Trafficking in the United States¹⁶

January 11, 2022

In the U.S., immigrants, especially immigrant women,¹⁷ make up the largest portion of trafficking victims. The Department of State estimates that in 2016, 57,700 victims had been trafficked into the U.S. annually. The true number is likely much larger and impossible to determine. In fiscal year 2021, there were nearly 2 million migrant apprehensions along the U.S.-Mexico border, and that number only accounts for the people encountered by border agents. More than 400,000 more migrants eluded apprehension and are counted among the “got-aways.” Last year also met another unfortunate record—147,000 unaccompanied migrant children entered into the U.S., 122,000¹⁸ were taken into the U.S. custody, the previous record being 69,000.

While some minors make it into the country with information on family members they have in the U.S., others end up in the foster system. According to the Department of State, a large number of child sex trafficking survivors in the U.S. were at one time in the foster care system. Being an immigrant places these children at a higher risk since they tend to have lower levels of education, an inability to speak English, and a lack of family and friends.

Sophisticated transnational syndicates are notorious for using children to get single, adult males not just across the border, but through Border Patrol processing. Once these men are granted a stay, they smuggle the children back across the border where they will continue to be trafficked. Studies done by the Latin American branch of the Coalition Against Trafficking In Women estimates that 60% of Latin American children¹⁹ who set out to cross the border alone or with smugglers have been caught by the cartels and are being abused in child pornography or drug trafficking.

In 2019, the Department of Homeland Security, under the Trump Administration, launched a pilot program that allowed for ICE to DNA test families that were deemed suspicious of

fraudulent activity. This program was designed to help prevent minors from being trafficked or recycled, and it resulted in criminal charges for the adults exploiting them. Yet this program was met with great disdain by activist groups and lawmakers and is not being used by the current administration.

Under the Biden administration, human traffickers are busier than ever, expediting the flow of migrants across the southern border. The President has made it abundantly clear that his administration does not wish to stop illegal immigration, nor does it wish to enable necessary enforcement of the immigration laws that are on the books. It is factors such as these that drive large numbers of people to surge the border, overwhelming federal and local agencies and—most importantly—risking the lives of millions.

With the Border Patrol overwhelmed by the large number of migrants to process, they are being compelled to get people through as quickly as possible, leading to a less rigorous vetting process. It is unknown how many victims of human trafficking have been smuggled across the border to date, but it is clear that scandalously loose border policies and inadequate federal resources incentivize innocent people to put themselves at the mercy of human smugglers, fueling human trafficking in the United States.



US Is a Top Destination for Child Sex Trafficking, and It's Happening in Your Community²⁰

July 25, 2023

The crisis at the southern border is directly linked to an increase in child trafficking in the United States. In April, a whistleblower told Congress²¹ House Judiciary Committee that the “United States federal government has become the ‘middleman’ in a multibillion-dollar human trafficking operation targeting unaccompanied minors at the southern border.”

In May, U.S. Customs and Border Protection encountered an average of 435 unaccompanied minors²² per day. One study suggests²³ that drug cartels and traffickers will exploit 60% of these children in prostitution, forced labor, and child pornography. To make matters worse, in June alone, the Biden administration released 344 kids to non-related adults in the U.S.—most of whom already had multiple children in their care.²⁴ These children are prime targets for traffickers—for sex or labor.

Notably, half of U.S. Immigration and Customs Enforcement's “most wanted” criminals²⁵ for child trafficking are from Mexico.

Biden slammed for declaring January Human Trafficking Prevention Month as border smuggling hits new highs²⁶

December 29, 2023

"It's just disgusting that he wants to declare human trafficking awareness month," Tom Homan, former acting director of US Immigration and Customs Enforcement, told The Post.

"If anybody needs to be aware of human trafficking, it's him. He's enriched the human traffickers because of his lack of enforcing the border," Homan said. "They're making record amounts of money moving record amounts of people because of his intentional un-securing of the border."

Mark Morgan, former acting commissioner of US Customs and Border Protection, said: "President Biden's open border policies have undeniably unleashed a persistent tidal wave of illegal immigration pouring across our borders, resulting in the United States being complicit in the world's largest human smuggling and trafficking operation in modern history."

The White House released the proclamation amid reports that 276,000 people were detained for illegally crossing the southern border in the first 27 days of December, exceeding September's record of nearly 270,000 over the same period.

"They come over, then they've got to pay off fees and a lot of them don't even know what they're getting into — some of the women are forced into prostitution, others are forced into labor," Homan said of migrants awaiting asylum decisions across the US.

"There are over 400,000 [unaccompanied] children that have been smuggled across the border [since 2021] and there's already been three or four separate investigations finding these children working in meatpacking plants at midnight²⁷ and being in forced labor, not going to school," he added. "That's the work of traffickers."

**Note: It's clear that evil is flourishing under the Biden administration. His deliberate destruction of our border, Constitution, laws, culture, and sovereignty is allowing evil to run rampant. These policies must be stopped, but they can only be stopped if we Secure and Win...*

TRAFFICKING AND RADICAL GENDER IDEOLOGY

- Put a wedge between children and their parents, and brainwash them into thinking their parents are the bad guys? **Check.**
- Teach children to keep secrets with adults who aren’t their parents, excluding their actual parents? **Check.**
- Introduce children to completely inappropriate sexual imagery and discussions without permission, and do it early so it is normalized and their natural inhibitions are eliminated? **Check.**
- Confuse children and teach them to mistrust their instincts, making them vulnerable to predators? **Check.**

The reason we call many teachers and school administrators “groomers” is because they are literally doing the things that pedophiles do to win the trust of a child in order to abuse them!

We must stop schools from teaching “comprehensive sex ed” and destroying our children’s minds and bodies with radical gender ideology. Grooming is gateway to child sex trafficking as 'seducing' moves online²⁸

June 16, 2018

Colombian traffickers used to pose as rich, older men promising a better life; now they pretend to be poor, troubled teenagers just like the children they target, said Sebastian Arevalo, head of anti-trafficking group Pasos Libres Foundation.

"Trust is now gained through empathy and emotions," Bogota-based Arevalo, who has talked to hundreds of students about the dangers they face online, told the Thomson Reuters Foundation.

"Recruiters are of similar age (to their victims). They say, 'I too have problems at school and with my parents', 'I've also broken up with my partner'."

From the United States to the Philippines, a soaring number of young people are being trafficked online, fueled by the global spread of cheap, high-speed internet and rising mobile phone ownership, particularly in developing countries.

About 750,000 sexual predators worldwide are online at any given moment, the U.S.-based International Centre for Missing and Exploited Children said last year, often grooming children for sexual abuse as a first step to enslaving them.

Grooming involves befriending children, mostly aged 11 to 15, to gain their trust, before luring or coercing them to send sexual images or videos of themselves, which are shared online on password-only group networks and websites, experts said.

"Grooming is the precursor phase," said Hernan Navarro, head of campaign group Grooming Argentina, which educates parents and children about the risks of social media.

"It's the gateway to more serious crimes like human trafficking."

Ballard spoke about the nexus of ideas between a pro-pedophile political party in the Netherlands and the Left’s transgender advocacy in the U.S., and he raised the alarm about Biden border policies that fund and enable the exploitation of children.

Ballard said he had studied the political platform of the Dutch Party for Neighborly Love, Freedom, and Diversity (which goes by PNVD, its acronym in Dutch).

In studying the PNVD’s literature, he discovered what he calls “the pedophile network doctrines.”

“They include things like: (1) separate children from parents, because parents are a bad influence, the state knows best; (2) sexualize kids, let them see pornography; (3) take God out of education because that just gets in the way; and (4) kids consent, consent, consent. Children can consent to anything,” Ballard said. “At 12 years old, they should be able to vote. They should be able to do anything.”

“Now, what am I seeing here? My stomach is getting sick as I’m reading this. I read this every day. It’s the woke Left agenda,” the child liberator said.

“I’m not saying that they’re colluding or talking,” Ballard said, referring to the Left and the PNVD. “It doesn’t matter. It’s the same dark source. But, pedophiles are sitting back right now, going, ‘We’ve been pushing this agenda for decades. and now we don’t have to push anymore, because the Left are taking care of it for us in America.’ In America!”

The former DHS agent also warned about “this whole trans [ideology] foisted on children.”³⁴ He said he would fight for the right of adults to “do what you want,” but children are a different story. “What they’re saying is, children can consent to having their bodies filled with a chemical that will destroy their reproductive system. They can consent to ripping apart their genitalia.” “This is insanity—in and of itself it’s horrible,” Ballard added. “But what it’s going to lead to is what the pedophiles have been asking for. If you can consent to that, guess what? What’s more fluid than gender? Age.”

**Note: In every way, at every opportunity, Joe Biden and his administration promote and defend actions that mutilate children’s minds and bodies. HOW TO WRITE A LETTER TO THE EDITOR

What is a Letter to the Editor?

A letter to the editor is a letter written to the Editor of a newspaper. The letter is an opportunity for you to express your opinion about a recent article published in the paper or an issue in the news.

Writing letters to the editor is an important engagement tool for activists. They allow activists to do the following:



1) Reach a broader audience than you normally would have;



2) Hold your local journalists accountable;



3) Present alternative views on political issues.

Letters to the editor are usually found in the first section of the newspaper or on the editorial page.



GUIDELINES FOR GETTING A LETTER TO THE EDITOR PUBLISHED

Most newspapers publish guidelines with their specific requirements for getting a letter published, but here are some general rules that will help you get your letter to the editor published.

- **Include your name and address and a telephone number** where you can be reached.
- **Be respectful and courteous**, even when disagreeing with the Editorial Board about a specific issue.
- **Be specific.** If you are opposed to Obamacare, mention the specific reasons why. Provide examples.
- **Cite your sources.** If you include any quoted material, be sure to correctly cite your source or attribute the quote.
- **Use proper grammar.** Spellcheck your letter and be sure to use proper grammar. Refer to *The Elements of Style* for a great overview of effective writing.
- **Be concise.** Letters to the editor are much more likely to be published if they are 300 words or less. Make your point as clearly and concisely as possible.

HOW-TO HOST A SIGN/FLAG WAVING EVENT

When the Tea Party movement started, there were only 22 people who committed around the country to hosting events. None of those 22 really had any idea if people would show up or not. Still, they knew they had to bring attention to the out of control government. You may not have a lot of people join you the first week or two you host a sign waving event. Keep going anyway. This is important to do. Have the courage to make your voice heard even if you do not know how many others will be there with you. Know that you will NOT be alone as others around the country will also be participating simultaneously around the country.

- 1 Secure a location.** You will want your event to be at an intersection with heavy traffic to maximize visibility. Confirm with local officials that you are allowed to wave signs at this location. As an alternative, you may also want to sign-wave right outside the office of your member of Congress.
- 2 Make signs.** Use the kind of messaging found in the sample social media posts or the sample letter to the editor. You can use sign/flag waving events to help you draw attention to the issue and to recruit people to serve as poll workers and poll watchers or to do get out the vote activities.
- 3** If you meet regularly, **have one sign say something to this effect:** “We’ll be here every Thursday at 5:30 pm – Come join us!”
- 4 Advertise your event.** Use your Facebook and other social media to let all of your activists and friends know about the event.
- 5 Invite the press.** Notify local press (TV, radio, and newspapers) that there will be a street rally on (for example) Thursday at 5:30 pm and invite them to attend.
- 6** On the day of the event, **send an email reminder** to all of your group’s members.
- 7 Take pictures!** Be sure to take pictures of your sign waving event. Email the pictures to us at photos@teapartypatriots.org or text them to **(404) 996-1717** and also be sure to post your pictures on your Facebook page and any other online forums that you use.
