THE PROBLEM

First, the 1993 National Voter Registration Act (NVRA) mandated that states accept the federal voter registration form. The federal form contains a box for potential voters to check to indicate that they are citizens - but that's it.

The law doesn't require documentary proof of citizenship to register. When states tried to add a requirement for documentary proof like Arizona did, they were sued, and eventually the Supreme Court ruled that because the NVRA did not include language to require documentary proof, states could not add that requirement.

Additionally, the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) allows people to register and vote by email without any residence in the United States, and without ID or proof of citizenship. Originally meant to help military personnel and their family members vote, in actuality, it's an invitation for foreign nationals to meddle in our elections.

Another vulnerability is that student IDs are considered approved identification to vote in almost every state. However, foreign students also get student IDs when they are students. Student IDs do not indicate citizenship. How many foreign students are voting in our elections?

Finally, we must look at Executive Order 14019. Joe Biden issued this EO on March 7, 2021. While President Trump signed an executive order overturning EO 14019 right away, we still must look at what Joe Biden's EO did. It ordered every federal agency, and those offices present in every state, to provide registration information to everyone who came into contact with that office/agency. Note that many federal agencies interact with noncitizens every day.

Now, with all of that information, think about this: There are (at least) over 21.7 million potential noncitizen voters. According to the Census Bureau, almost 22 million noncitizens were residing in the United States in 2022. **However, we know that number increased significantly as a result of four years of Joe Biden's open border.**

More: 19 States & DC Issue Driver's Licenses to Illegal Aliens. And every state issues driver's licenses to noncitizens. None of these IDs indicate citizenship status on them. Federal law requires the use of driver's licenses or social security numbers to confirm voter eligibility, but both are issued to noncitizens - thus creating a dangerous loophole that allows noncitizens to register . . . and vote.

Finally, 85% of Americans Agree: Only Citizens Vote. 87% agree proof of citizenship should be required when registering. The far-left is ignoring the vast majority of Americans who agree that only United States citizens should be able to vote in United States elections.



THE SOLUTIONS

FEDERAL LEVEL: THE SAVE ACT

Tea Party Patriot's Action supports the SAVE Act (Safeguarding American Voter Eligibility) introduced in the U.S. House of Representatives by Rep. Chip Roy (R-TX) and in the Senate by Sen. Mike Lee (R-UT). The SAVE Act will preserve the integrity of federal elections by ensuring that only U.S. citizens can participate in voting.

The Act proposes significant amendments to the National Voter Registration Act (NVRA) by mandating documentary proof of U.S. citizenship and identity during voter registration, regardless of the registration method. It also establishes mechanisms for removing noncitizens from voter rolls and facilitates access to federal databases for this purpose. Furthermore, the legislation expands the rights of citizens to sue election officials who fail to enforce these requirements.

While only U.S. citizens can legally vote in federal elections, federal law has significantly undermined state laws requiring proof of U.S. citizenship for voter registration.

The SAVE Act would restore Americans' confidence that only U.S. citizens can vote in Federal elections by:

- Requiring that proof of citizenship accompany the federal voter registration application that every state must accept.
- Mandating that states establish a program to remove noncitizens from their existing voter rolls using data provided by the Department of Homeland Security and the Social Security Administration at no cost to the states.
- Empowering U.S. citizens to bring civil lawsuits against election officials who fail to require proof of citizenship to register to vote in Federal elections.
- > Creating criminal penalties for persons who knowingly register noncitizens to vote in Federal elections.

STATE LEVEL

- 1. If an identification or permit to drive is issued to noncitizens, ensure that it is clearly discernible as a noncitizen permit or identification ONLY. Remember, noncitizens are not always illegally here. Some are legally in the USA, but they are still not allowed to vote.
- **2.** Ensure that noncitizens are not being registered to vote at the DMV or other state agencies.
- **3.** State election officials must create a process in cooperation with the DMV and social services agencies to ensure that noncitizen registrations are not included in the registrations forwarded from DMV and social services agencies to the state election offices.



"IT'S ILLEGAL, SO IT'S NOT HAPPENING."

This is the most common pushback that we hear from those who **don't, for some reason, want** to ensure that American citizens are the only ones voting in our elections.

It's true that the 1996 Illegal Immigration Reform and Immigrant Responsibility Act makes it a deportable offense for noncitizens to register to vote and to vote. However, as previously mentioned, there are many holes that allow noncitizens to do both of these activities. Below is a bullet list of points that demonstrate the "it's illegal, so it's not happening" argument is easily dismissed.

- The National Voter Registration Act (NVRA) of 1993 and the Uniformed and Overseas Citizens Absentee Voter Act (UOCAVA) do not require documentary proof of citizenship to register to vote.
- The NVRA requires all states to accept the federal voter registration form. In 2013, the Supreme Court ruled in *Arizona v. Inter Tribal Council of Arizona* that states did not have the authority to add a requirement for documentary proof of citizenship to the federal form.
- The UOCAVA does not require an ID to vote when voting from overseas.
- Legal noncitizens are eligible for driver's licenses and other IDs, including the REAL ID. 19 states and DC issue driver's licenses to illegal aliens. Even where voter ID is required, the driver's licenses and state voter ID cards do not indicate citizenship.
- Public Interest Legal Foundation <u>has been documenting cases</u> of foreign nationals registering to vote and voting for the past decade.
- Joe Biden's Executive Order 14019, issued shortly after taking office, required all federal agencies and their offices across the country to offer voter registration to anyone who interacts with the agency, using the federal form. Again, the form does not require documentary proof of citizenship to register. President Trump signed an executive order overturning this on the first afternoon of his second term, but we don't know how many noncitizens took advantage of Biden's order first.
- Over the four years of Joe Biden's presidency, millions of illegal aliens entered the country. They interacted with many federal agencies for various reasons. As there is no requirement for documentary proof of citizenship, and the agencies were required to offer voter registration forms to everyone, nothing stood in the way of noncitizens registering to vote.
- Finally, it is laughable to claim that laws aren't broken. We all know laws are broken every day. It's called crime. People do illegal things every day, despite *knowing they might be caught and punished*.

HOW TO WRITE A LETTER TO THE EDITOR

WHAT IS A LETTER TO THE EDITOR?

A letter to the editor is a letter written to the Editor of a newspaper. The letter is an opportunity for you to express your opinion about a recent article published in the paper or an issue in the news.

Writing letters to the editor is an important engagement tool for activists. They allow activists to do the following:



1) Reach a broader audience than you normally would have;



2) Hold your local journalists accountable;



3) Present alternative views on political issues.

Letters to the editor are usually found in the first section of the newspaper or on the editorial page.



GUIDELINES FOR GETTING A LETTER TO THE EDITOR PUBLISHED

Most newspapers publish guidelines with their specific requirements for getting a letter published, but here are some general rules that will help you get your letter to the editor published.

- Include your name and address and a telephone number where you can be reached.
- **Be respectful and courteous**, even when disagreeing with the Editorial Board about a specific issue.
- **Be specific.** For instance, if you are opposed to DEI, mention the specific reasons why. Provide examples.
- **Cite your sources.** If you include any quoted material, be sure to correctly cite your source or attribute the quote.
- Use proper grammar. Spellcheck your letter and be sure to use proper grammar. Refer to A.I. services (ChatGPT, Gemini, etc.) for an tips and ideas for effective writing.
- **Be concise.** Letters to the editor are much more likely to be published if they are 300 words or less. Make your point as clearly and concisely as possible.



SAMPLE LETTER TO THE EDITOR

Dear Editor,

August has been designated **Only Citizens Vote Month**, a nationwide effort to remind the U.S. Senate that safeguarding our elections is neither partisan nor optional. In fact, in polling done in January 2024 and July 2025, four-in-five voters agree that proof of U.S. citizenship should be required when registering to vote in American elections.

At the center of this campaign is the **SAVE Act**, a bill that already passed the U.S. House and finally closes the citizenship loophole created by the National Voter Registration Act of 1993. That 30-year-old law requires states to accept a federal registration form that asks applicants to attest they are citizens—but never to prove it.

With millions of noncitizens—both legal and illegal—now living in the United States, this deficiency is no longer theoretical. Any ballot cast by someone who is not a citizen cancels out the ballot of an American who is. One person, one vote becomes a hollow promise.

The **SAVE Act** restores common sense: applicants would submit the same documentary proof of citizenship required, for example, to obtain a passport. No honest voter is disenfranchised. Imagine traveling to any other country and demanding to vote—no one would call that a civil right. Why should our country accept a lower standard?

This August, please join me in contacting your U.S. Senators to urge them to pass the **SAVE Act** as soon as possible. Election integrity unites Americans of every party and background—again, four-in-five voters also agree that only U.S. citizens should vote in U.S. elections.



Below is an email that you can send to your friends and network, encouraging them to take action for Only Citizens Vote Month. Copy and paste the "Sample Message to Senators" below your email message, so that they can use the template to craft their emails to officials.



I am reaching out with important information that every American needs to know: There are major gaps in our voter registration laws that allow noncitizens to vote in U.S. elections.

Specifically, the National Voter Registration Act (NVRA) of 1993 and our Uniformed and Overseas Citizens Absentee Voter Act (UOCAVA) left glaring holes in the election registration process.

These holes in the NVRA and UOCAVA allow noncitizens to register to vote and then vote, plain and simple. There is no actual verification of citizenship when using the federal registration form - and every state is required to accept that form. When you fill out the federal voter registration form, you check a box stating that you are a citizen. That's it. No proof needed. And, with overseas voting, you can register and vote without ever proving citizenship or showing ID.

But wait, there's more! Every DMV, social service agency at the state level, and every federal agency and all of their offices across the country were required, under the Biden administration, to provide registration information to everyone who did business with them—with zero requirements to ask about citizenship status. So, if noncitizens received IDs, or signed up for benefits, or did anything with any federal agency or office, they were given the chance to register, because remember, no proof of citizenship needed.

All of that leads me to say, **the Safeguarding American Voter Eligibility** or **SAVE Act** is an extremely necessary piece of legislation that will restore integrity to our elections in the following ways:

 Requiring that proof of citizenship accompany the federal voter registration application that every state must accept.

- Mandating that states establish a program to remove noncitizens from their existing voter rolls using data provided by the Department of Homeland Security and the Social Security Administration at no cost to the states.
- Empowering U.S. citizens to bring civil lawsuits against election officials who fail to require proof of citizenship to register to vote in Federal elections.
- Creating criminal penalties for persons who knowingly register noncitizens to vote in Federal elections.

This is not a partisan issue. This affects every American citizen, no matter which party you prefer. Every illegal vote dilutes the vote of a citizen. The U.S. House already passed the SAVE Act, and we should all come together and demand that U.S. Senators—who represent the citizens of the United States of America—pass this legislation immediately to ensure that only citizens are voting.

Additionally, we can push for changes to our state constitution (if needed) to specifically ban noncitizen voting, we can pass resolutions in favor of banning noncitizen voting, we can advocate for IDs that indicate noncitizen status, and more.

Please join me in contacting your U.S. Senators, urging them to support and vote for the SAVE Act as soon as possible. Phone calls are really effective, but it's helpful to send messages through the online contact forms found on their official government websites as well. I'm including a message below that you can copy and paste to make it easy to send them a message.

SAMPLE MESSAGE TO U.S. SENATORS

To send a message to your U.S. Senator, you need to use the online form that is found **on their official websites**. You may copy and paste this message into the form, and we highly encourage you to also print out the <u>Sample Letter to U.S. Senators</u> page, sign it, and deliver it to your senators' local offices during the August recess.

I am a constituent and I am writing you this letter to make clear my position on the very urgent issue of securing American Elections through the Safeguarding American Voter Eligibility Act (SAVE Act).

As a citizen of this great nation, I want to encourage you to vote in favor of closing the glaring holes in our voter registration system so that I, and other Americans, can feel confident in our election process and outcomes.

The SAVE Act addresses the major vulnerabilities caused by the NVRA and UOCAVA that allow noncitizens to register to vote and then cast a ballot, even though the 1996 Illegal Immigration Reform and Immigrant Responsibility Act makes it a deportable offense. While many want to deny that this happens, the reality is that it does and there is nothing in the law that requires proof of citizenship to register to vote.

This is not a partisan issue. Polling commissioned by Tea Party Patriots Action in January 2024 and July 2025 show that over 80% of voters agree that proof of U.S. citizenship should be required when registering to vote in American elections.

Democrats, Republicans, and Independents want to ensure that only U.S. citizens are voting, so that our votes are not diluted by illegal, foreign votes. There are no good reasons for arguing against closing these loopholes. It is past time to bring the SAVE Act to the floor for a vote and for every U.S. Senator to vote yes on the SAVE Act and save our elections!

While the 1996 Illegal Immigration Reform and Immigrant Responsibility Act makes noncitizen voting a deportable offense, nothing today prevents the ineligible from registering or casting a ballot.

Voters across the political spectrum want those loopholes closed. January 2024 and July 2025 surveys commissioned by Tea Party Patriots Action found that **over 80 percent of voters—including large majorities of Republicans, Democrats, and independents—believe proof of U.S. citizenship should be required to register to vote in American elections**. Opposition comes from a fringe, not the mainstream. Our election system should unite, not divide, the country, and restoring confidence in the voter rolls is a critical step.

I respectfully ask that you:

- 1. Cosponsor the SAVE Act, if you have not already done so;
- 2. Press Senate leadership to bring the bill to the floor without delay; and
- 3. Vote Yes on final passage.

Thank you for your service and for considering the views of your constituents. I look forward to your reply and to seeing you stand with the vast majority of Americans who believe that only citizens should choose their government.


POLL RESULTS

The vast majority of Americans agree that only citizens should register to vote and only citizens should vote. In January 2024, Tea Party Patriots fielded a poll with McLaughlin and Associates about this issue.

The poll, which surveyed 1,000 voters and was conducted January 25-31, 2024, found:

- > 87% agree that "proof of United States citizenship should be required to register to vote in American elections."
- 86% agree that "only United States citizens should be allowed to vote in elections in America"

HOW TO ORGANIZE FOR PETITION SIGNING

Organizing a group to go door-to-door to encourage voters to sign a petition is similar to door knocking during an election year. You need to know your material, understand your audience, and articulate your talking points well. Getting petition signatures is an effective way to let Congress know the American people support a certain cause.

- **1. Make it a team effort.** Invite your friends and family to join your petitioning session and set a time table—usually 1-2 hours depending on where you go. You can break into smaller groups and cover more ground.
- **2. Everyone has a role to play.** Assign tasks based on the strengths of your team:
 - > Petition Presenter: Explains the petition and asks for signatures
 - Note Taker: Records contact info or notes about conversations
 - Navigator: Plans the route or uses a map to track doors visited
- **3. Plan a Fun Kickoff.** Host an in-person or virtual gathering before your hit the pavement.
 - Share a 2-minute overview of the petition and its impact
 - Hand out or share a one-page "cheat sheet" with key talking points (e.g., why the petition matters, how signatures will be used)
 - Assign roles and pick a date, time, and neighborhood to canvass
 - Make it social—plan to grab a meal or drinks afterward to celebrate your efforts

4. Equip Your Team.

- Ensure everyone has clipboards, pens, <u>petition forms</u>, and documents to leave behind
- Talking Points: Practice a 15-second pitch together (like: "Hi, I'm [Name], and we're collecting signatures to secure American elections. It'll take 30 seconds to sign and help us make a difference!")
- Safety and Etiquette: Remind the team to stay polite, respect "no" answers, and stick to public spaces. Go in pairs for safety and comfort

Pro Tip: Make It Personal! When recruiting, tap into what your friends or family care about. For example, if your cousin is huge 2nd Amendment supporter, highlight how the petition aligns with that. If your friend is social, emphasize the team spirit and fun of working together for a cause you both care about.



HOW-TO HOST A SIGN/FLAG WAVING EVENT

You may or may not have a lot of people join you at a sign waving event. Do it anyway. This is important to do. Have the courage to make your voice heard even if you do not know how many others will be there with you. Know that you will NOT be alone because the vast majority of Americans agree that only citizens vote!

- **1. Secure a location.** You will want your event to be at an intersection with heavy traffic to maximize visibility. Confirm with local officials that you are allowed to wave signs at this location. As an alternative, you may also want to sign-wave right outside the office of your member of Congress.
- **2. Make signs.** Use the kind of messaging found in the sample social media posts, the sample letter to the editor, or the sample letter to Congress. For example:
 - "Tell the Senate to Pass the SAVE Act: Only Citizens Vote!"
 - "The SAVE Act: Save American Elections!"
 - "SAVE Act. Save America. Only Citizens Vote!"
 - "Secure Elections: Only Citizens Vote!"
 - "Noncitizens can vote. This must stop! Pass the SAVE Act in the Senate!"
 - "Don't dilute the citizen's vote! Stop illegal voting!
 - "Tell [insert senator's name] to vote for the SAVE Act!"
- **3.** Have one sign say something to this effect: "We'll be here every Thursday at 5:30 pm Come join us!" (Note: only create this sign if you are going to try to meet regularly. For instance, until the SAVE Act is passed and signed into law.)
- **4. Advertise your event.** Use your Facebook and other social media to let all of your activists and friends know about the event.
- **5. Invite the press.** Notify local press (TV, radio, and newspapers) that there will be a street rally on (for example) Thursday at 5:30 pm and invite them to attend.
- **6. On the day of the event,** send an email reminder to all of your group's members.
- 7. **Take pictures!** Be sure to take pictures of your sign waving event. Email the pictures to us at photos@teapartypatriots.org and also be sure to post your pictures on your Facebook page and any other online forums that you use.



HOW-TO HOST AN ICE CREAM SOCIAL

Inviting friends and family for a get together is a great way to inform and mobilize those who are ready to take action! The goals for an Ice Cream Social are to have fun meeting with friends and neighbors, help inform and educate on serious matters, and invite guests to take action at the event, build a community of like-minded people. Below are some easy to follow steps to get you started.

1. Set event details & invite guests:

- Choose your day, time, and location.
 - Send out an invitation to guests. This could be through text messages, emails, in person, calling, sending an invitation through the mail, online post (i.e. Facebook event), etc.
 - Your message should include the "when, where, what, and why" of your event.
- The event should last about 90 minutes including the call to action.
 - Your event should include telling people about the problem and the solution
 - Then have guests sign the petition and make calls to their U.S. Senators. If it's on a weekend or evening, simply have them leave a voicemail.
 - You can also print out copies of the letter to U.S. Senators in this guide so that your guests can sign them. Then you can deliver them later to the senators' local offices.
 - Try to recruit your guests to do other activities with you, such as gathering more signatures, hosting their own ice cream social, etc.

2. Prep for the event:

- Buy your favorite flavor of ice cream, cones, toppings and other supplies.
- > Send a reminder to those who have RSVP'd a few days in advance and/or the day of the event.

3. Host the event:

- Allow your guests to mingle and eat ice cream for 30 minutes or so
- Read "The Problem" and "The Solution" pages aloud, and the n outline the action steps you'll complete at the event.
- Settle into the action steps, i.e., signing the petition, making phone calls, or signing letters – use the script and letter template we provide in this guide

4. After the event:

- **Follow up with Tea Party Patriots Action.** Send photos and copies of your petitions to **photos@teapartypatriots.org**.
- Follow up with attendees and share other calls to action for Only Citizens Vote Month.
